# PRODUCT INSTALLATION GUIDE TeraFlex JK FlexArms

The following guide will assist you in installing your new JK Monster FlexArms. Due to the innumerable tire size and lift height combinations, control arm lengths will vary from Jeep to Jeep. The lengths provided should merely be used as a <u>starting reference length</u> for any lift height. Fine tuning the length will be necessary for a proper caster angle in the front and pinion angle in the rear in addition to centering the tire in the wheel well. A four wheel alignment will need to be performed following FlexArm installation.

Replace each factory arm with the TeraFlex FlexArm one at a time. For the lower arms, the rubber bushing should be installed at the frame end. Each FlexArm has a sticker to identify and locate the arm. Install the arm so the sticker faces up. Set the pinion angle about two degrees low if the Jeep has a double-cardan drive shaft. If the drive shaft has factory style Rzeppa joints, the pinion should be inline with the drive shaft. Grease the Flex Joints in the arms every 3000 miles or sooner.

NOTE: When only four adjustable arms are installed, front lower and rear upper adjustable arms should be installed. Use kit #1653700 for the front lowers and #1654840 for the rear uppers in order to set the pinion angle. Use a starting length of 17 7/8 inches.
